What is "Riot control law" ?

Hanging noose for Hindu society, few people will know about this bill, in 2011 the design of this bill was made by Sonia Gandhi's special team which was also called NAC..

in this team more than a dozen there were more members and all were the same who are called Urban Naxalites nowadays. Congress said that through this bill they will stop the riots in the country. Now take a look at the many provisions in this bill :-

Cont ■

There was a provision in this bill that no Hindu judge could hear any case related to minority registered during the riots.

If a minority just alleges that I have been discriminated against, then the police had the right to put you in jail without hearing your side...

and in these cases the judge will also be a minority..

A provision was made in this bill that during the Hindu riots, violence, arson, sabotage cannot file a case against the minority community for

Provision was made in this bill that..

Cont ■

if a person belonging to a minority community accuses a Hindu of violence, arson, sabotage, murder, then it is not his responsibility to present evidence in the court, only registering a case is enough. Rather, it is the responsibility of the person to be proved innocent in court.

In this bill, a provision was made that the loss of the minority community should be compensated by the Hindu, holding the majority responsible for any kind of loss caused to the minority community during the riots...

Whereas the minority could not be held responsible for the loss of the majority.

If there is a vacant room in your house and a Muslim comes to your house to ask for rent, then you could not refuse to give him the room because all he had to say..

was that you gave him the room because he was a Muslim. That is, we could not do anything against any minority who molested your sister and daughter. Meaning that if someone teases then keep teasing or else he will accuse you of anything....

your direct arrest and the judge from above is also a minority..

There would have been a riot in any part of the country, even if it was a Muslim-majority area, whoever started the riot, but only adult Hindu men of that area were to be blamed..

for the riots and the investigation would start by registering a case against them. And even in this situation the judge would be only a minority, in any such riot, whoever started it...

Cont ■

If any Hindu girl or Hindu woman is raped in the area of ■■riots, then it is not considered as rape. The majority is Hindu, therefore the rape of her woman will not be considered as rape & not only this, if a Hindu woman becomes a victim of rape & she goes to complain..

Cont ■

then the case of spreading hatred against the minority would have been put on her separately.

There was another proposal in this act, under which the police would have caught you, if you asked what crime you have committed..

Cont ■

then the police would have said that you have committed a crime against the minority, then you would have asked the name of that minority, then the police Says - No, the name of the complainant will be kept secret..

Cont ■

There was also a provision in the Congress's Riot Control Act that any area, the majority would have to take NOC of the minorities there before any of their religious programs, that is, they do not have any problem with the program...

Cont ■

In such a situation, minorities would earn Jajiya sitting because you had to take their NOC before doing any religious work, and they would recover money from you and if you complain, then the case of discrimination is on you and in such a situation the judge is also minority..■

There were many other provisions in this riot control law of Congress which is also called Communal Violence Bill in English. Subramanian Swamy was the first to start the opposition to this bill and when he told people about this bill, Hindus were trembling in 2012..
