Rudy Insurance Thread 1/

America's Vampire, the notorious serial butt-dialer and former attorney, Rudy Colludy once threatened the sitting US President with his 'insurance' files. Giuliani clearly thought Trump fears his evidence. Let's explore this 'tremendous' legal gambit

Can Rudy escape prison by bargaining with his notorious 'insurance' file? Ah... that is where this gets interesting

A normal criminal could well perhaps manage to do that. Negotiate a deal, and use the evidence in that bargaining. But not Giuliani



Rudy Insurance Thread 5/

The NORMAL criminal negotiates with prosecutors, telling them in a 'proffer' session what kinds of crimes the perp can confess to, & specifically, who else they can implicate as partners in that crime. It only really works if they can give someone 'big'



Rudy Insurance Thread 6/

In those negotiations typically the perp enter into a deal with prosecutors, then go through often weeks, even months of reviewing the evidence the perp has, that can perhaps be used to convict the bigger criminal/s. Not with Rudy though...



Rudy Insurance Thread 7/

Rudy had a MAGNIFICENT evidence file as his evidence, not just against Trump, but other Trumpomobsters, like Pompeo, probably Bill Barr, most def at least some of Trump kids, and Jared. Plus misc mid level Trumpocrooks like Lev Parnas, Igor Fruman etc

But Giuliani lost all LEVERAGE when the FBI took the evidence in the raid of Rudy's office. Oopsie. Now Rudy cannot 'deliver' any evidence. Worse. Rudy did not know, he was under wiretap. Therefore most of his co-criminals are ALSO ALREADY CAUGHT on tape
