SK Mishra started to build ED

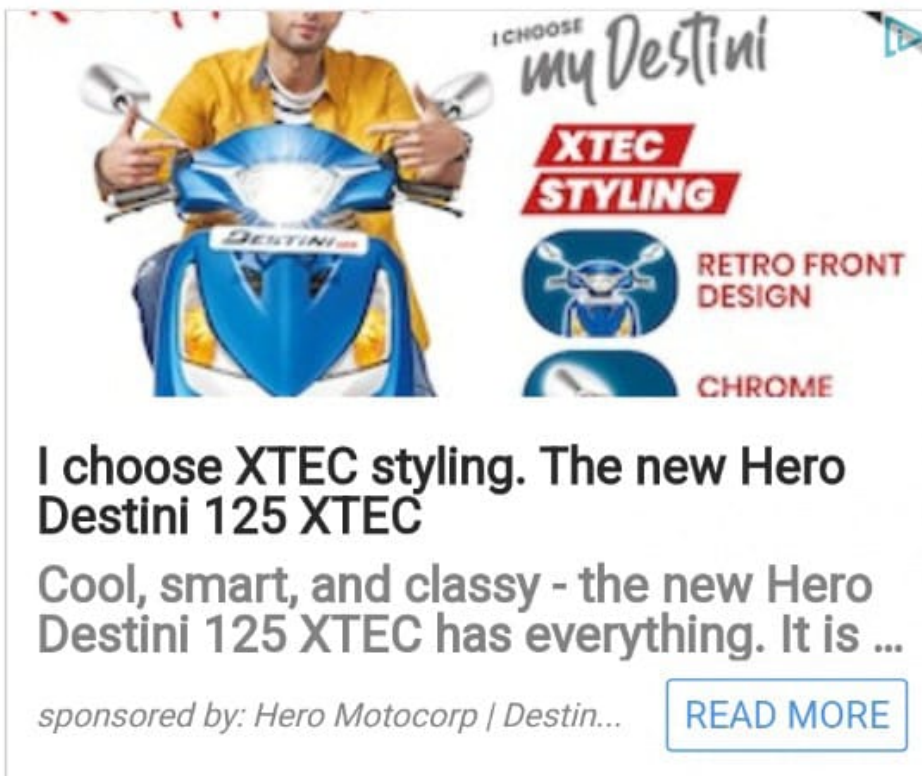
before him there was hardly 23 senior officers, now there r more than 100 senior officers.

But his 2 years tenure was till Nov 2020 since in India CBI director n ED directors r appointed for 2 years or till age of 60 whichever occurs earlier.

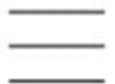
SK Mishra finished his 60 years in March 2020 but Central kept him continue.
