

Facing \*allegations\* from multiple parties. One, a 15 year old "superfan" accuses Coady of goading them towards suicide, supply of drugs and alcohol, hitting, choking, and emotional abuse.

They stated that, "Sharon has vehemently denied the allegations against her, and is prepared to defend herself against this individual to the fullest extent possible." The Daily Beast subsequently provided Coady's lawyer with a full summary of the allegations to be reported in this story but received no further response, despite multiple weeks of follow-up requests for comment.

Annecy also alleged that Alaska Thunderfuck, another *Drag Race* winner, exposed themself to Annecy on the cruise. "It was the first penis I ever saw and it was when I was 15, and there was no consent."

They recall FaceTiming with Coady frequently over the next two years, and described an unhealthy power dynamic that bordered on life-threatening. Makes this list for also being found guilty of abducting a 15-year-old boy.


