

## Twitter Thread by <u>AB against UCP</u>






I took a drive down the 22 yesterday to check out a #monolith that popped up in the Crowsnest Pass area! Went to investigate, left realizing the <u>@UCPCaucus</u> is likely involved, in a bad way, as usual

If you haven't driven down the 22, it is gorgeous - rolling foothills, streams cutting through picturesque ranch land, and a rugged mountain landscape background. Near Maycroft provincial park, right near the Crowsnest pass is where this thing stands, approx. 12 feet tall.



It sounds like the Tin Man from Oz when you knock on it and looks to be made of shiny sheet metal. Seems to be mounted firmly into the ground, with no visible supports



Its similar to others I've seen, only in pictures, but has an additional feature: what appears to be an extra component that seems to indicate the monolith is 'pointing' to a larger swath of area, rather than strictly in the direction of the acute triangle shaped object's 'point'



If that is the case, it looks to point towards a chunk of the eastern slopes of Southern Alberta. A chunk that happens to be where the proposed Grassy Mountain Coal mine would be located.

I dont know who erected it (didn't look like the work of aliens to me, sadly) but as <u>@bestbertwistle</u> noted (and where i read about this first), maybe someone is trying to point out the environmentally destructive proposed coal mine project an Australian corporation is proposing?



The project, Grassy Mountain, has tons of serious impacts not just to the local environment, wildlife, and landscape, but significantly impacts the water supply for hundreds of thousands. Coal mining is a dirty operation.

- The proposed Grassy Mountain coal mine will destroy the upstream water quality and quantity of the Crowsnest River and upstream tributaries that flow through the proposed project;
- The project will remove millions of tons of overburden which will be dumped into adjacent valleys polluting watercourses including the Oldman watershed which is the source of water for hundreds of thousands of Albertans;
- The project will create impoundment ponds which will leach selenium in high concentrations into the surrounding environment destroying existing agricultural and recreational activities for decades;

How is this being allowed, you ask? The <u>@UCPCaucus</u> recisnded the 1976 land use policy for coal mining in the eastern slopes, and are facing court challenges for allegedly not legally consultation. Of course, announced Friday before May long weekend <u>https://t.co/tR4TY9jeUl</u>

Landowners and the Ermineskin and Whitefish Lake First Nations have filed separate requests for a judicial review of the decision, which they argue was made without legally required

consultations.

"It really focuses in on the lack of consultation our clients received," said Richard Harrison, lawyer for several ranchers whose grazing leases overlap with land now available for open-pit, steelmaking coal mines.

"That one act — on the Friday before the May long weekend — to rescind the coal policy really had a detrimental effect." Anyone recall the price for HUGE amounts of provincial land leased to these foreign companies? Not even \$36 bucks a hectare. Oh, thats for 15 years btw #UCPcorruption


