Sarah Baker from Juvenile Court is in attendance and provides commentary. They are looking to amend a contract with Applewood Center. Deputy Director Bridget is in attendance. Ms. Baker notes it is quite late for the application.

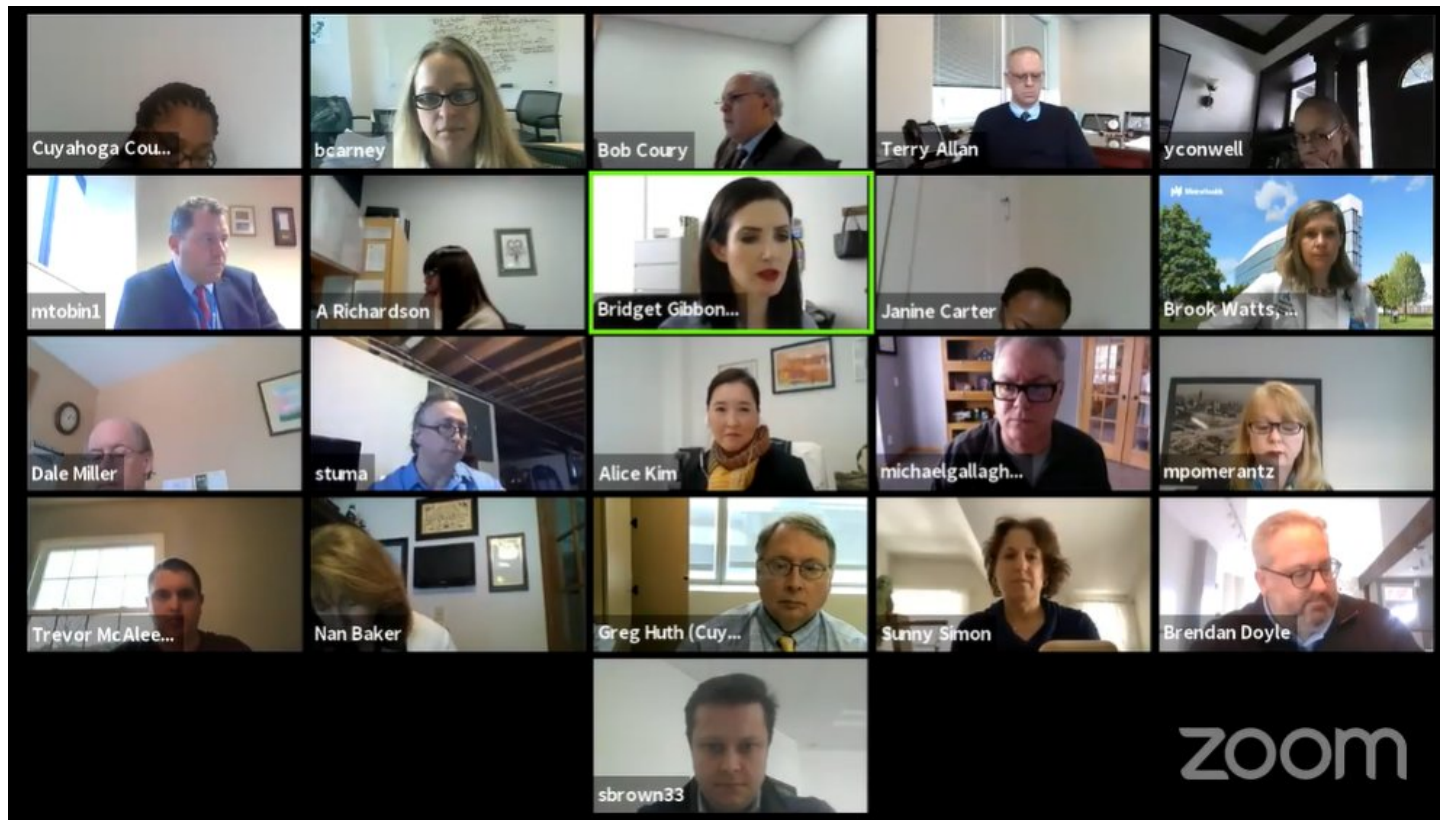
##### 5. MATTERS REFERRED TO COMMITTEE

- a) **R2021-0027:** A Resolution authorizing an amendment to Contract No. CE1600252-01 with Applewood Centers, Inc. for Multisystemic Therapy/Multisystemic Therapy-Problem Sexual Behavior Services for adjudicated youth for the period 7/1/2016 – 6/30/2020 to extend the time period to 6/30/2021, and for additional funds in the amount not-to-exceed \$600,000.00; authorizing the County Executive to execute the amendment and all other documents consistent with said award and

Despite the late request, the funds are necessary.

Deputy Director Bridget provides commentary on the resolution request.

Note: she is highlighted in green.



Dep Dir Bridget reflects on the wide-ranging services the program provides. Funds primarily focus on the care givers. It has a 90% success rate.

Member Conway: how long does child stay in the program?

Dep Dir Bridget: 150 to 180 days is the average stay in the MST program.

Cuy Coun Member Conway: What is the overall contract amount prior to his request?

Juvenile Court's Sarah Baker: I am pulling the amount up. Last year we added 550,000.

Cuy Coun Member Conway: You are requesting \$600,000. What is the purpose of the additional amount?

Juvenile Court's Sarah Baker: It is mostly to address the additional cases.

Cuy Coun Member Conway: What is the amount of children targeted per year?

Juvenile Court's Sarah Baker: We try to target a minimum of 60 children per year. Right now we have 25 youth.

It is cost-effective when we divert away from residential treatment. It costs 9,000 per you versus residential treatment of 30,000 to 50,000 per youth.

Member Gallagher: Due to the lateness of the request, I imagine you'd wish we move on this judiciously.

Mem Gallagher moves to pass resolution. It is backed by Mem Conway. It is passed.

Agenda item 5(b) R2021-0028 is an amendmen to a current Contract No.

CE1600133-02 that provides tasers and body cameras to 5th district. They are requesting \$1,604,401.46.

- b) R2021-0028: A Resolution authorizing an amendment to Contract No. CE1600133-02 with Axon Enterprise, Inc. fka Taser International, Inc. for Taser body cameras for the period of 7/1/2016 – 12/31/2023 to extend the time period to 12/31/2025, to change the scope of services, effective 4/1/2021, and for additional funds in the amount not-to-exceed \$1,604,401.46; authorizing the County Executive to execute the amendment and all other documents consistent with this Resolution; and declaring the necessity that this Resolution become immediately effective

Cuy Co Member Gallagher: Asks if there is anyone from legal here concerning substituting the contract for another. Why is the contract extending to 2026? How did this become about? Why?

Greg Huth: Explanation needs to come from department. I was not involved with this resolution.

Cuy Co Member Gallagher: Who submitted the proposed substitute?

Sherrif's Department: We submitted an incorrect date previously. The date change is to give a full 12 months

Cuy Co Member Gallagher: so if I understand it correctly, the current contract ends in 2023 and this one extends to 2026?

Sheriff's Department: That is correct.

Cuy Co Member Gallagher: The concern to me is that we don't normally do beyond a 3 year contract.

Sheriff's Dept: The program (h Axon Enterprise, Inc. fka Taser International, Inc) contracts in 5 year increments.

Cuy Co Member Conwell: In the contract it states that the contract is funded from the General LE funds. What is the General LE Funds?

Sheriff's Dept: I don't know why it states that, it is just the general fund.

Cuy Co Member Conwell: You stated it is a 5-year contract, this extension would extend beyond 5 year.

Sheriff's Dept: It is starting from 5 years, that is, if this amendment is passed it would run from 2021 to 2026.

Sheriff's Dept: This amendment came about because we were seeking additional body cameras and tasers. We are already locked into a current contract so wished to amend it to acquire the items.

Cuy Co Pres Jones: How many tasers are being purchased?

Sheriff's Dept: We are purchasing 215 tasers. We have 208 tasers currently. We want extras in stock in case one is use, stored for an investigation, or breaks down.

Cuy Co Pres Jones: Is the same amount for body cameras?

Sheriff's Dept: No, only the deputy sheriffs and sergeants. Lieutenants and Captains are not currently needed.

Cuy Co Pres Jones: Why not body cameras for everyone?

Sheriff's Dept: Lieutenants and Captains aren't in the field interacting with the public often where as the Deputy Sheriffs and Sergeants are.

Cuy Co Member Miller: What are the purposes of the tasers? To what extent does use of the tasers cause injury?

Sheriff's Dept: They are less lethal option to use during someone arresting arrest. There is a quick, several second burst of electricity.

Usually, after arrest the person is fine. We do provide medical treatment if necessary

Cuy Co Member Miller: How often were they used in 2020?

Sheriff's Dept: I would have to compile the data, but I believe it was ten times. Every time a taser is used, a use of force document is filed.

Cuy Co Member Conway: The use of the tasers used before or after handcuffs?

Sheriff's Dept: Before the handcuffs, so one does not have to go hand-to-hand combative.

Cuy Co Member Conway: Training? How often?

Sheriff's Dept: Axon will provide trainings to all the employees. In-service training is once a year. There is additional specialty training.

Someone from the dept notes that it is against their policy to tase someone in handcuffs.

Cuy Co Member Gallagher proposes to move proposed substitute R2021-0028. It has been seconded and approved.

R2021-0028 has been moved for a second reading and has been approved.

Cuy Co Member Gallagher wishes to be sensitive to time and the discussion of Agenda Item 6(a) a) Cuyahoga County's vaccine distribution schedule and procedures. Discussion on RO2021-0001 will be delayed.

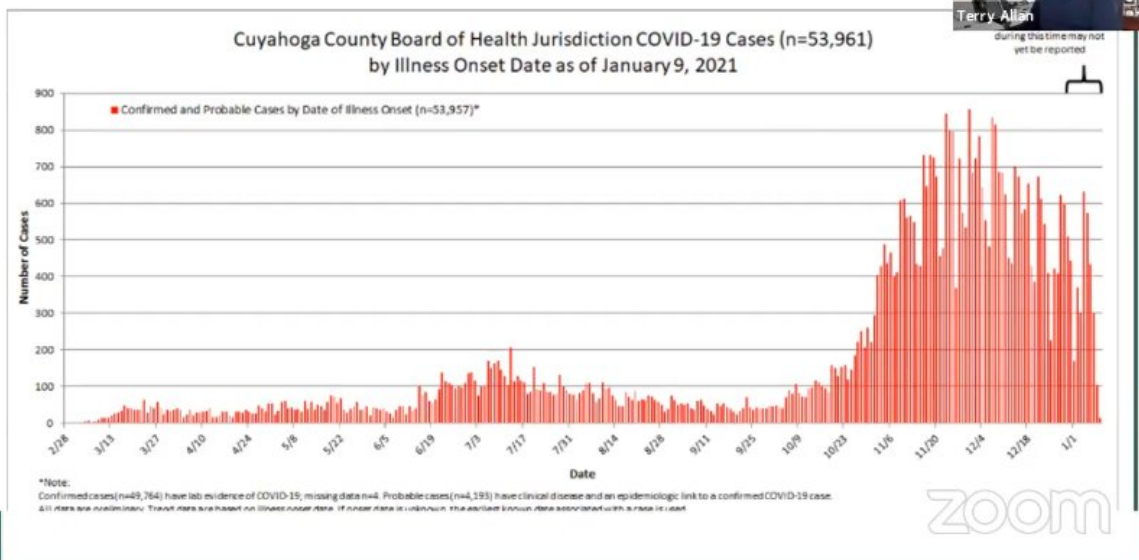

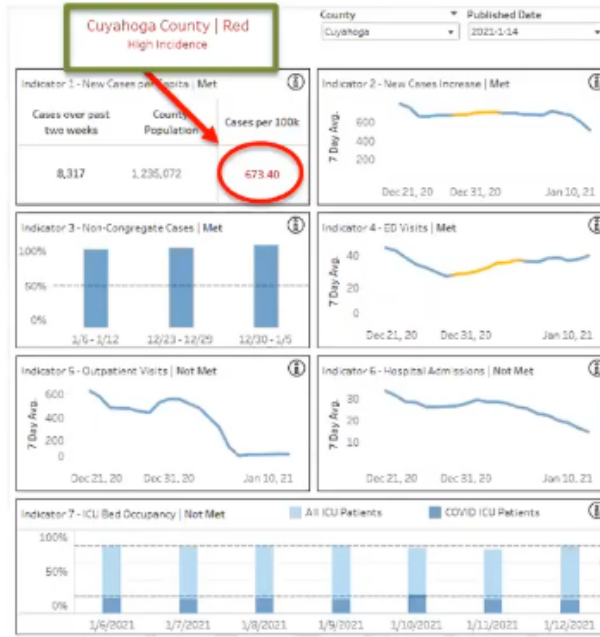
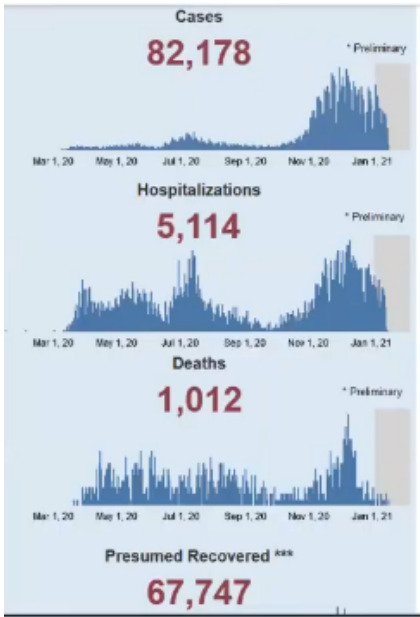
A data chart tracking the trends of COVID-19 from 2020-02-28 to Present.

# Case Investigation and Contact Tracking

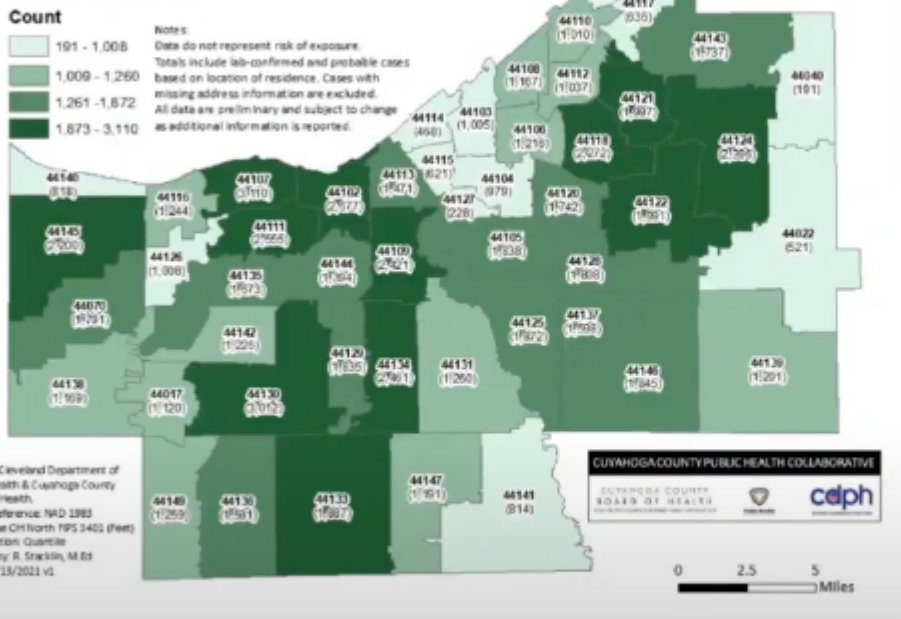


We are currently a red county. We are six times the recommend CDC level for threshold of transmission. When examining zip code we see that people move around a lot and the virus does not care about zip codes.

## Reported COVID-19 Cases by Zip Code Cuyahoga County, OH (through January 9th)

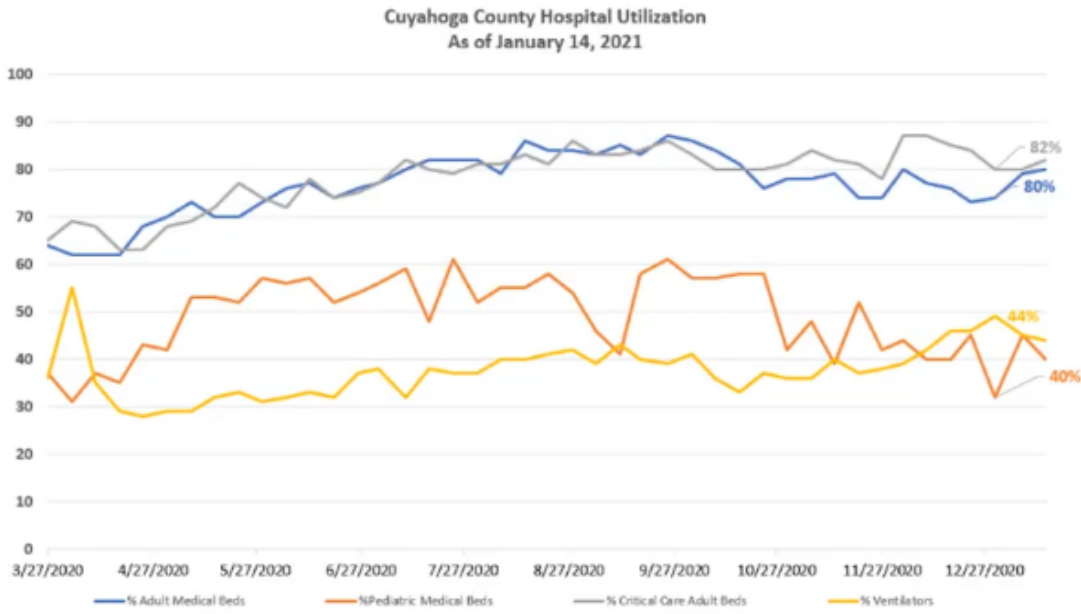

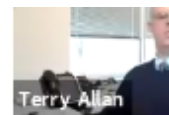

Dir Allan presents Ohio's Vaccination Program phase which Cuyahoga County is following.

**Ohio's Vaccination Program**  
*- A Phased Approach*

**GOALS** Save lives and slow the spread of the virus. In the early vaccination phase, supply will be limited. The speed at which Ohio will move through the phases is largely dependent upon the number of vaccine doses available.

**PHASE 1** **Supply Limited**  
Vaccine is available in limited supply for specific critical populations. Ohio will focus on vaccinating those most at risk, as well as essential healthcare workers and personnel caring for COVID-19 patients. Vaccines will not yet be available for all Ohioans.

**PHASE 2** **Supply Increasing**  
Vaccine is increasing and available for other specific critical populations who choose to be vaccinated. Vaccines will not yet be available for all Ohioans.

**PHASE 3 - 4** **Widely Available**  
Once the vaccine is widely available, Ohio will continue to strategically vaccinate Ohioans if they choose. During these phases, vaccines will begin to be available to all Ohioans.

*As supply increases, COVID-19 vaccines will be available to all Ohioans who **choose** to be vaccinated.*

We are in Phase 1. There is a high demand for the vaccine but low supply. Phase 1A focuses on essential workers like Health Care Workers and Personnel, Residents and Staff at Nursing Homes, Assisted Living Facilities, and Hospitals.

## Anticipated Phase 1B vaccination providers

- Not all Phase 1B providers will be allocated vaccine initially.
- Allocations will be made on a rolling basis as vaccine doses become available.
- Initially, allocation modeling will be population-based to determine how much vaccine each county will receive.
- Vaccine allocation will eventually be determined based on capacity across vaccination provider channels.
- Primary care and home health providers will be added as more vaccine becomes available.

# Future phases: Who is next



You may receive questions from the community about where a certain group falls in line: **When can I get the vaccine?**

- Eligibility dates are available only for population groups in phases 1A and 1B.
- As supply increases, more populations will be offered the vaccine.
- If the population hasn't been announced yet, its timeline is still being determined for future phases.
- Eventually, all Ohioans who choose to receive the vaccine will receive it.

Dr. Brooke Watts of Metro Health notes that they have begun Phase 1A, vaccination of their employees, and Phase 1B vulnerable seniors. The number 1 barrier for Phase 1B is awareness & accessibility for seniors to receive. The second barrier is the lack of vaccine available.



Dr. Alice Kim of Cleveland Clinic shares their experience and thanks Terry Allan as well as all the hospital partners in the area. The great barrier is the supply chain. The issue isn't connecting to the community, it is the access to the vaccine.



Dr. Alice Kims of Cleveland Clinic notes that we are trying to reach out and educate all of our patients.

Sam Brown of University Hospitals doesn't have much to add, seconds the other opinions. They have vaccinated the majority of their staff (Phase 1A) & are now on Phase 1B but have the same problem which is access to the vaccine. He like the other hosp reps shows gratitude to all.

Cuy Co Member Gallagher: Is there any indication from the Feds about access to more vaccines?

Dir Allan: Every Monday morning around 10:00am we have a call with the Governor. From the last call, we will not see much change in the coming weeks for vaccine flow.

Dir Allan: Beyond that we hope to see an increase. Right now, our allocation for vaccines is splitting 1A and 1B individuals. 50,000 doses came this week. Lots of people deserve access but this is where we are at.

Cuy Co Member Gallagher: Is there a targeted approach with mailings for awareness of the vaccine?

Dir Allan: We get lots of phone calls.

Cuy Co Member Gallagher: So not a lot of mailing? From what I know about senior citizens, they aren't comfortable with modern tech.

Cuy Co Member Gallagher: It would be better to have mailings.

Nan Baker: It usually takes 5 to 8 years for a vaccine. The fact we have it within 1 year, we have a vaccine. This is amazing!



Nan Baker: She encourages us to reflect if we are prepared for mass vaccinations once the supplies do arrive.

Dir Allan: Based on the experience with H1N1, we have been using drive thrus. If there is a large enough footprint, it can be done inside.

Dir Allan: Generally, we believe we can handle mass vaccination if the supply is there.

Alice Kim of Cle Clinic: Yes, we do have the capacity to provide mass vaccination, but the supply chain issues are the concern. The hospitals are coordinated and working together.

Nan Baker could not hear the previous responses and asks her question again.

Alice Kim of Cle Clinic states her above answer again: YES!

Sam Brown seconds Alice Kim's opinion that the hospitals are able to provide if the vaccination supply increases dramatically.



Cuy Coun Member Miller: I've been reading about large scale vaccination distribution clinics. Is this on your radar?

Dir Allan: As the hospitals have stated, we have the distribution capacity and we are coordinated. There are other places working together like pharmacies.

Dir Allan: The goal is to have the vaccination in every corner.

Cuy Coun Member Miller: Are we going to get weekly vaccinations?

Dir Allan: We have received 15,000 doses weekly and we expect that to stay the same for the time being.

Cuy Coun Member Gallagher: If someone contracted COVID, do they need the vaccine?

Brook Watts of Metro Health Hospital: CDC recommends getting everyone vaccinated. If you have contracted COVID, you are an eligible candidate as you may contract COVID-19 again.

Alice Kim: Though there may be a 90-day waiting gap to receive the vaccine if you have already contracted COVID-19 as your body has developed a natural response which we may consider when administering the vaccines.

Cuyahoga County Executive Armond Budish reflects that the Governor supports Terry Allan's approach to spread the vaccination as widely as possible for the public accessibility.



Cuy Coun President Jones: At the local level, have you seen hesitancy in the African-American population? If so, what efforts have been made to overcome these challenges?

Dir Allan: Yes, we have heard concerns in the African-American community about going first. We are attempting to address the concerns in the community whether it is with doctors or faith-based communities. There is a lot of work on messaging.

Dr. Brook Watts of MetroHealth: I am in Cleveland Heights and my anecdotal experience today is that there are many African-American seniors willing to get vaccinated.

Cuy Coun President Jones: What about nursing homes?

Dir Allan: Yes, vaccination rate among nursing home staff is lower than the residents. It is 75 to 80% of residents willing to get vaccinated versus 40% of the staff willing to get vaccinated.

Cuy Coun President Jones: Raising the 40% of Nursing Home staff needs to be addressed. The challenge is of education. I believe seeing the success of the vaccine and that it will not harm you will lead to many more people signing up.

Nan Baker:

Dir Allan: What I hope and dream about at night is a return to normal.

Nan Baker: Because we are targeting the most vulnerable, shouldn't we see the death rate to drop?

Dr. Brooke Watts of MetroHealth: Great question but we do not know yet. There is wide community spread.

Cuy Coun Member Gallagher: According to public reporting, ~33% of vaccine distributed to Ohio has been used. Does that mean ~66% has not been used.

Dir Allan: We continue to do our best and there is variability in response of certain systems. We can do better.

Cuy Coun Member Gallagher: I ask as if it is true, it would seem the state is dragging its feet as we at the county level are ready. Dir Allan, please inquire with the Governor.

Dir Allan: It was our assumption, that there was a federal stockpile

Dir Allan: but that those federal doses in the stockpile are not available and eventually flow will increase.

Nan Baker: Are we holding back doses for 2nd doses for nursing homes?

Dir Allan: Certainly possible.

Dir Allan: CVS and other companies are helping administer the vaccine.

Cuy Coun Pres Jones: Do they administer at their business or the nursing homes?

Dir Allan: They will go into the Nursing homes.

Cuy Co Member Gallagher: We should take our time with these. We should not be rushing.

Cuy Co Member Conway: There will be 7 members on this board?

Greg Huth: Yes, with different lengths of service.

Cuy Co Member Gallagher proposes substituting Ordinance No. O2021-0001. It is seconded and approved by the Council.

Cuy Count Member Gallagher notes the spirit of the legislation is to have outside community members involved to reflect diversity, not the Council Members.

Cuy Count Pres Jones seconds the purpose is to reflect community diversity.

Cuy Co Member Gallagher moves for a second reading of RO2021-0001. It has been approved and a second reading will occur.

Agenda Item 6(B) BC2020-677 is up.

Ronnie from the inmate correctional discusses the history of the relationship between Bedford Heights & the County Jail. It is a \$4,000 monthly payment.

Bob Coury states that Bedford Hghts had to be paid due to contractual obligations.

- b) BC2020-677: Sheriff's Department, requesting authority to prepare an amendment to Agreement No. 348 with City of Bedford Heights for lease of the Bedford Heights Jail, located at 5661 Perkins Road, Bedford Heights for the operation of County jail facilities for the period 10/1/2017 – 9/30/2027, to change the scope of services by assigning full responsibility for transportation, housing, maintenance and general upkeep of the Bedford Heights Jail to the City of Bedford Heights, effective 12/21/2020 and for additional funds in the amount not-to-exceed \$32,000.00.

Funding Source: General Fund

Cuy Co Member Gallagher: I don't like being held over-a-barrel due to contractual obligations. We had Euclid over-a-barrel once but did not act inappropriately. I would like to wait for the eyes of the new Sheriff.

Cuy Co Pres Jones: The entire criminal justice system needs to make an effort to keep the jail numbers below 1,000. It needs to be sustainable and manageable levels. Tough-on-crime is not effective and is a dinosaur. We need all hands on deck to keep the jail population low.

Nan Baker: how does the diversion center play into this? That was supposed to help those who should not be in jail in the first place.

Cuy Co Member Gallagher: It should help according to the terms of the Diversion agreement. When it is up and running and if it runs correctly.

Cuy Co Member Gallagher: Terms are good but the action has yet to happen. Things are in the pipeline.

Bob Coury notes that around summer time action should start with implementing the Diversion Agreement.

Cuy Co Member Gallagher: The new jail should be announced soon. We want to move faster but COVID-19 has delayed it. Again, I'd like to kick BC2020-677 until the new Sheriff is implemented.

Cuy Co Member Simon: We need to wait and see. The numbers are down to low indictments

Cuy Co Member Simon: due to no grand juries due to covid-19. We need to wait and see.

Cuy Co Member Gallagher: I still think we should wait for the new sheriff to provide input.

Bob Coury: Further discussions need to happen concern many aspects of Cuyahoga County and the jail business.

Cuy Co Member Gallagher: This was a long meeting but important. The next meeting should be in two weeks.
