Thread: This thread explains how Edappadi Palanisamys Highways Dept is involved in huge tender frauds. 2 area based comprehensive road improvement strengthening & maintenance contracts for laying and widening thanjavur roads worth Rs 656 Cr & Rs 494 Cr were floated in Oct 2020



Many roads in excellent conditions were included for maintenance for 5 years. One wud think that d cost of maintaining good roads will be lesser than usual. However, while earlier tenders had cost of Rs 1 Cr/Km, these 2 tenders were given Rs 3.15 Cr/Km & Rs 1.95 Cr/ Km resp.

I have received a specific input that AB-CRISM tender 2020_HWAY_182929_1 with tender value Rs 655,60,00,000 has again been prefixed for 'RR Infra Construction' and AB CRISM tender 2020_HWAY_182935_1 with tender value Rs 493,70,00,000 has been prefixed for 'JSV Construction'. I have also heard that the other bidders will just be dummy bidders to enable the above to win tenders.

The results of these tenders have now come out & @Arappor was spot on with respect to the contractors who will win these tenders. Its not a matter of any mathematical probability prediction but a sheer fraud done on the ppl of TamilNadu by CM's Highways Dept by prefixing the tenders

Earlier these tenders were floated together as Performance based maintenance contract & they were also cancelled in July after Arappor named the winner RR Infra even before the tender was opened. The fraudulent practise by CMs highways Dept is there for all to see

Firstly, these r not e tenders. Participants hv to get machinery/ plant certificate from Highways engineer that requires bidders to go and meet them physically to get it. Its learnt that bidders r told that d tender has already been prefixed for a specific person by the top!

Thats how physical points of contact & requirement of certificate from officials help in prefixing these tenders by not allowing others to participate. Contractors who try to legally fight these come under heavy political pressure and they withdraw cases like this tender.

If these 2 tenders were given cost as per earlier similar tenders which is Rs 1 Cr/Km, then d entire 2 tenders together wud only cost Rs 462 Cr. The current cost stated in Rs 1150 Cr. The difference is Rs 688 Crores in just this on tender. Its all our tax money!

Now will CM Edappadi Palanisamy & Highways Secretary Karthik IAS take action on these fraudulent tenders. If they dont take action, what is their role in this fraud which is prima facie Corruption ? I dont need to state the obvious as each of you know the truth!
