**The UK government is reportedly planning to install former Daily Mail editor Paul Dacre as chair of the broadcasting regulator OFCOM. Some background:**

Polls have consistently shown that the UK public currently has a much higher level of trust in TV and radio media than they do in the UK newspaper industry, which has consistently been found to be the least trusted in Europe:

The UK public's low level of trust in our newspaper industry should perhaps come as no surprise. In 2016 the Daily Mail and Sun were both called out for "fuelling prejudice" in an international report on rising racist violence: <https://t.co/mdwZoWPtqf>

In 2015, the United Nations spoke out, condemning "decades of sustained and unrestrained anti-foreigner abuse, misinformation and distortion" in the UK press: <https://t.co/maP2ZIEIrL> /4

By contrast, UK broadcast media are currently held to a much higher set of standards. Although not perfect, OFCOM has strong powers to tackle racist and hateful coverage within TV and radio, eg: <https://t.co/hXjbtkgU2s> /5

This is markedly different from the situation in the United States, where broadcasting regulations are much weaker. In the US, channels such as Fox News have been able to free to operate in ways which - currently - would not be allowed by OFCOM /6 <https://t.co/EFpocKwGI5>
