Ready?

Incoming rant, but serious ■.

It really and truly was high-intensity, aimed, microwave radiation that caused “Havana Syndrome” (permanent brain damage) in US and Canadian diplomats while they were stationed in Cuba and China in recent years.

In order to even begin claiming justification here, the theoretical crimes would have to have been so heinous and obvious as to require skipping all of those foundational steps of legitimate proceedings...

...and go straight to carrying out a punishment of permanent, physical, and mentally debilitating harm inflicted via high-energy microwave beams fired at, and into, the brains of these US & CA government employees and officials.

All while invited to these foreign countries where they were stationed and lived while adversarial enemies of our nations intentionally fired brain-damaging weaponry, munitions commonly known to cause harm to the human body, upon these diplomats _and_ their families_.

...If you go with that narrative, you either are, or are aiding, the enemy. You may be doing so unintentionally, or at the direction of someone who told you what to say or write, or perhaps without sufficient knowledge of the...

...details to realize the gravity of what you are doing.

The bottom line is that commentary trying to brush aside these assaults on our diplomats and which attempts to sweep the well documented harm of this new form of attack under the rug, provides aid and cover for the enemy.

A bullet which cannot be held, nor seen, nor captured on film in mid air as it hurls toward the a chosen target, is not any less lethal due to those characteristics. It should be understood as *more* alarming than conventional bullets because of its deniability.

Causing chaos within adversary ranks by inflicting unseen damage to the brain of a key decision maker is much more powerful than a single sniper's bullet taking down that same decision maker in plain view with the bloody-soaked evidence plainly visible to all.

...which then emboldens the resolve of that adversary force while unifying a nation's population against a common enemy believed to be responsible for the sudden and undeniable assassination event.

This scenario w/new tech now tries to achieve same goal w/out the unwanted parts.

The new-age invisible “bullets” do not inflict their full harm immediately. It is a pernicious, slow venom not any less dangerous than the projectiles used to kill on battlefields for the past ~200+ years.

But the harm is spread over time and attacks the faith in commands given. If you cannot trust the mental faculties of people in key decision making positions, the entire command-decision making structure breaks down. These forms of attacks...

...targeting individuals' ability to make reliable and accurate decisions, and be of sound mind, are a grave threat to human civilization and modern societies worldwide.

There is no way to justify this harm to diplomats.
It is an abhorrent & unacceptable use of technology.

Future generations will look to current times for a range of precedence and guidance.

The answer here to this one should be unambiguous: That we reject the use of invisible, covertly deployed, unannounced, and unexpected weapons to inflict brain damage in the a target. Full stop.

Microwave style weaponry is much more dangerous over time due to the degrading effect on quality of reasoning and decision making relied upon by all tiers of organization.

Implementing defense, detection, and countermeasures against this new type of attack must be done...

...with credibility in mind. Taking the threat posed by rogue use of Directed Energy Weapons seriously at a population-wide scale will require spreading a destabilizing truth- that a new weapon has been used to harm our diplomats abroad, and we need to understand the risk here.

Half of the harm caused by this type of weapon in modern times will be the result of an unwillingness to admit they exist or are possible.

Next, humanity needs to spread knowledge of how to detect the use of directed energy weapons (DEWs) and identify symptoms experienced by victims of the new class of long-term weaponry; and doing so in a careful enough way to not cause panic, yet remain serious about the threat.

There will be opportunists and trolls alike trying to cause panic for profit and laughs. They must be anticipated and countered with zealous clarity. The penalty for coordinating disinfo for profit, or to inflict undue and avoidable harm, must make it clearly not worth the risk.
