Swamy attended Hindu College, University of Delhi, from where he earned his Bachelors Honours degree in Mathematics. He then took his master's degree in Statistics from the Indian Statistical Institute,

Kolkata. He was later recommended by Hendrik S. Houthakker and went to study at Harvard University on a full Rockefeller scholarship, where he received a PhD in Economics in 1965.

His thesis adviser was Nobel Laureate Simon Kuznets. In 1963, while he was a doctoral student at Harvard, Swamy worked at the United Nations Secretariat in New York City as an Assistant Economics Affairs Officer. He subsequently worked as a resident tutor at Lowell House at Harvard University and in 1986, served as consultant to the World Bank.

Its important for us to understand wht is Rockefeller Foundation. John Rockefeller was businessmen from US who started funding various Churches & Universities to turn things in his favour, it was his way to manipulate & dictate his terms in

Rockefeller was a conservative Baptist who believed that a strong relationship with God was necessary for honest, meaningful, lasting work. For that reason he always sought to partner with other Christians who shared such views.

His Contributions

As was noted earlier, Rockefeller believed in the importance of generosity. In fact, he tithed ten percent of his first paycheck to his local church and maintained that discipline throughout his life. With his high value on education, Rockefeller helped fund colleges like Spelman College, which was named after his in-laws.

John Rockefeller was staunch Christian who gave funding to Missionaries to setup schools & Universities in Asia. His particular interest was in China, Vietnam, Philippines & also started funding big US schools like Yale, Harvard, etc. This allowed him to handpick his chosen ones

Rockefeller also supported missionary work. In 1905, he gave a grant to the American Baptist Missionaries to help establish Central Philippine University, the first Baptist University in Asia. He also supported Ivy League schools such as Yale, Harvard, and Brown. In 1913, he created the Rockefeller Foundation which gave to public health, medical training, and the arts. This foundation endowed Johns Hopkins and it built the Peking Union Medical College in China.

But he did not merely fund causes. He also invented certain ways of giving that are still used today. For example, he created the conditional grant, which promoted both recurring donations and the

Dean Rusk — A “Silent Buddha” Amidst Chaos



Dean Rusk served as Secretary of State for eight controversial years, from 1961 through 1969, when public discomfort over his daughter's interracial marriage prompted him to offer his resignation. (LBJ refused to accept it.) He ended up serving through the end of Johnson's term. Born February 9, 1909, David Dean Rusk spent his early years in Cherokee County, Georgia, but relocated to North Carolina to study at Davidson College. After graduating Phi Beta Kappa, Rusk studied in England as a Rhodes Scholar at St. John's College, Oxford. Following a few years as a staff officer in the China-Burma-India Theater

Dean Rusk's main task was to gain the control of Asia, especially China which was then under Communist rule of Mao & an ally of Russia. Later the Vietnam war & he also divided Korea.

Swamy did PhD in Economic growth & Income Distribution in Developing Nations (focusing on China)

Department, Rusk joined the Department of State in February 1945.

Secretary Rusk's term extended through the darkest days of the Cold War and included such conflicts and crises as the Bay of Pigs Invasion, Cuban Missile Crisis, [Vietnam War](#), [the Six-Day War](#) and the [Biafra famine](#).

Remembered by his Special Assistant, Emory C. Swank, as "even-tempered, considerate, and kind....with natural reserve and reticence and no fondness for small talk" and by historian Arthur M. Schlesinger Jr.'s as Buddha-like in "A Thousand Days," Dean Rusk was an interesting antithesis to the violent and unpredictable times in which he lived. Both valued and condemned for his reticence and equanimity, Secretary Rusk directed his skills at cementing compromises and avoiding the type of diplomatic fiasco which would trigger nuclear warfare. In this interview with Paige E. Mulhollan beginning back in July 1969, Mr. Rusk interprets his time in office, highlighting his respect for President Lyndon B. Johnson, his opinions on various regions and his predictions for the future.

How much good must a foundation do in order to justify investments in companies whose products cause harm? Take the Rockefeller Foundation, [which invests some of its assets](#) with Cerberus Capital Management, an American private equity firm that controls the gun manufacturer Remington. How many lives do the foundation's programmes have to save in order to rationalize how the money was generated?

Events in Brazil initially provided reason for optimism over the Foundation's approach. In 1930, one the world's most effective malaria vectors *A. gambiae*—inadvertently imported by ship from West Africa—was discovered in the state of Rio Grande do Norte in the country's North-East. Despite driving a series of epidemics, including in 1938 the largest ever documented in the Americas with over one hundred thousand cases and over fourteen thousand deaths,⁷⁵ *A. gambiae* was successfully eradicated in Brazil by 1940 under the direction of RF's Fred L. Soper.⁷⁶

Yet the eradication of *A. gambiae* proved to be false hope in the Foundation's larger bid to eliminate malaria in the countries where they operated solely through vector control. Both the social factors (e.g. illiteracy, poverty and poor quality land) and ecological factors (e.g. sheer variety of vectors and associated traits) underpinning disease transmission proved insurmountable for RF and their state partners.⁷⁷ Unfortunately for the world, the Foundation's successes with yellow fever would not be replicated with malaria.

4.13 – Building Epistemic Communities At the Country-Level

RF's limited ability to successfully control particular diseases in the first three decades of its existence distracts from its ability to establish through training communities of experts sharing common ways of conceptualizing and addressing particular problems within all of the countries where they operated. It is significant that partner governments readily accepted RF's offers to subsidize advanced training of civil servants because of a common volition for strengthening public sector capacities in public health (and later in agricultural science). This is because the Foundation's ability to successfully define or "frame" problems (i.e. their discursive power) relied not only on its record of science-enabled innovation but also its ability to forge like-minded epistemic communities within the countries where it operated. Moreover its instrumental power revolved around the fostering of epistemic communities at
