MDC-T legal battle looms

US wasting millions on Zim election process: Report

A BRUTAL legal showdown is looming between two main claimants to the MDC-T throne, Thokozani Khupe (right) and Douglas Mwonozora (left) — who controversially won the party's presidency at a chaotic extraordinary congress held in Harare on Sunday — after the former instructed her lawyers to file an urgent court application seeking the annulment of the election results.

The two erstwhile protagonists teamed up to dislodge firebrand youthful politician Nelson Chamisa from the helm of the party after successfully challenging the constitutionality of his ascendancy to its leadership at the Su-



preme Court in March.

However, no sooner had they succeeded than their paths crossed as they fought for the heart and soul of the opposition party. Mwonozora trounced Khupe by 883 to 118 votes, but she has refused to recognise the result saying the election was rigged.

Khupe held a press conference to immediately "suspend" Mwonozora.

She also suspended the congress in the middle of voting, citing rigging by Mwonozora.

The congress was characterised by violence leading Khupe to abandon the process along with the other presidential aspirants, Elias Mudzuri and Morgen Komichi.

Mwonozora's victory was announced in the wee hours of Monday by the MDC-T's



independent electoral management body.

Khupe, Komichi and Mudzuri disputed the process describing it as a sham.

Addressing a press conference at a local hotel in Harare yesterday, Khupe's spokesperson Kaliphani Phugeni confirmed that the matter was now being handled by lawyer Lovemore Madhuku, who has been tasked to prepare a legal challenge seeking an order nullifying the proceedings of the congress and Mwonozora's win.

"As I was coming here I was phoned by the party lawyer Lovemore Madhuku pertaining the issue. The matter is

THE United States (US) Senate has predicted Zanu PF leader, President Emmerson Mnangagwa, would win the 2023 presidential election despite Washington pouring in millions of dollars to democratise the country.

In a damning 2020 Festus report, presented to the US Upper House, senator Rand Paul on Monday accused the US Agency for International Development (USAID) of spending US\$10 million taxpayers' money on a futile attempt to help reform Zimbabwe's political processes, especially elections.

He described the process as a waste of funds as they would not help unset Mnangagwa whom he tips to retain the presidency by "hook or crook" in 2023.

According to Paul's report, the Congressional Budget Office says the 2020 fiscal year deficit was an eye-watering US\$3,1 trillion, with some expenditure traceable to COVID-19 related spending, but a lot of it was spent ostensibly without care on unnecessary programmes including "an already rigged 2023 forthcoming Zimbabwean election".

The report went on to say although Mnangagwa promised to be a reformer on his ascension to power after the military removed long-serving ruler Robert Mugabe from power in a November 2017

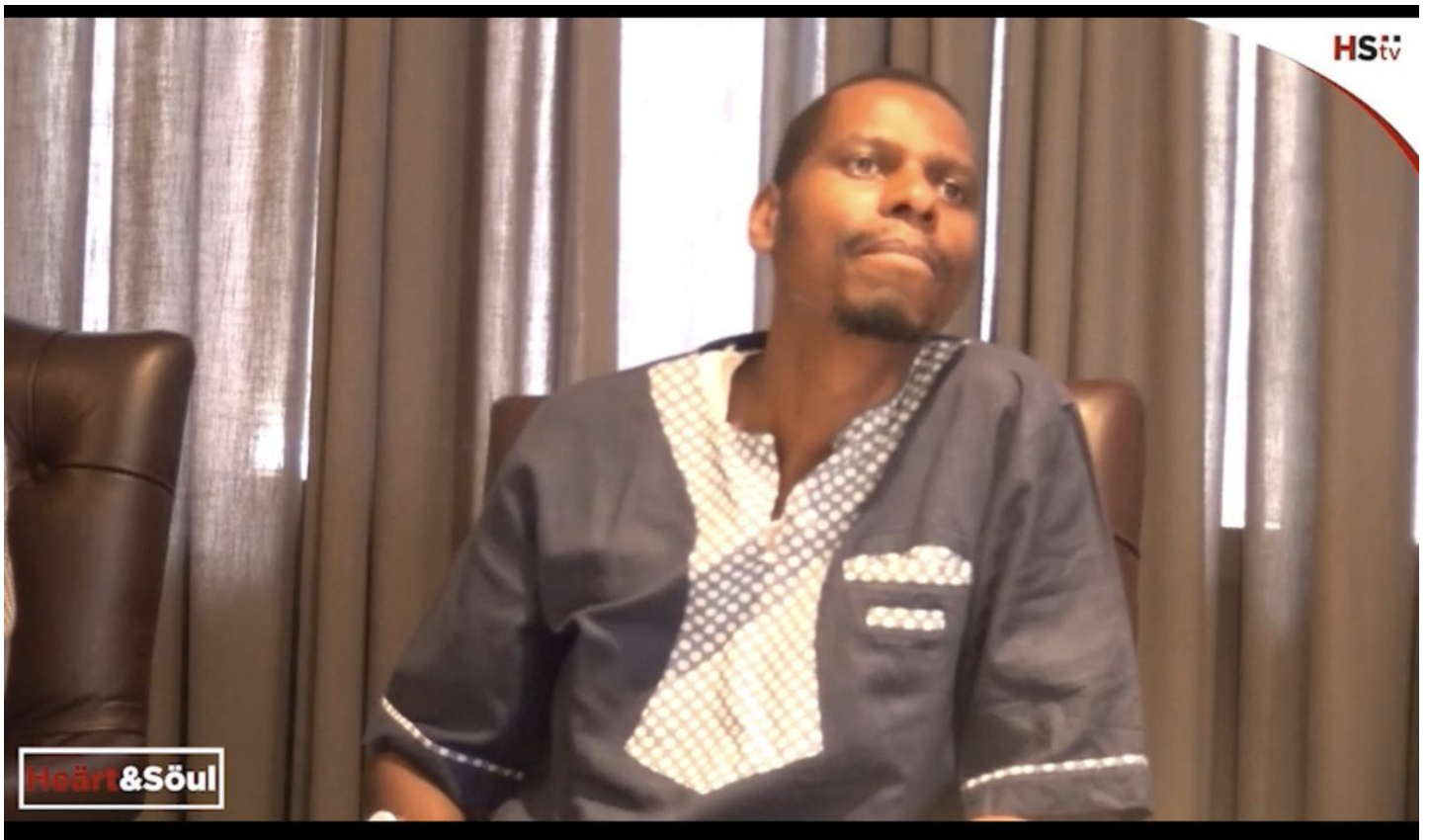

NATIONAL COUNCIL MEETING RESOLUTIONS

28 Dec 2020

Upholding and Respecting the Supreme Court Judgment (SC56/2020) which ordered the holding of an EO C in terms of the party constitution to elect a substantive replacement for the late Party President Dr Morgan Richard Tsvangirai.

(i) acknowledge the 31st March 2020 Supreme Court judgment

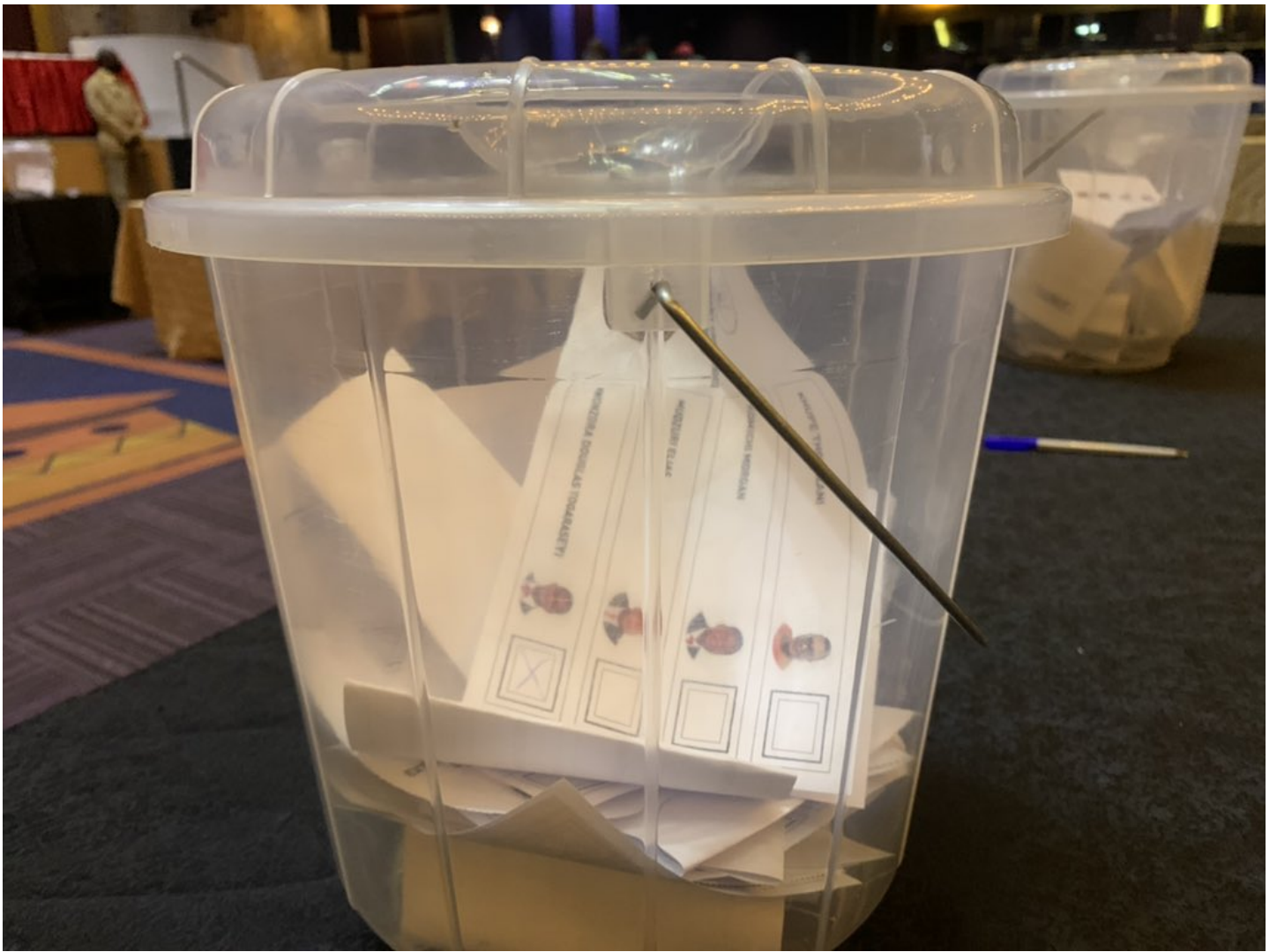
(ii) . go for the ordered EO Congress in line with the party constitution

Reiterates its adherence to its



Founding Values and Principles of Constitutionalism, Transparency, Democracy, Accountability, Fairness as well Nondiscrimination among others.



Condemns increasing illdiscipline exhibited by some members of the party and is calling upon all to moderate behaviour to be in conformity with the founding values and principles of the party.



Acknowledging that the EOC was an MDC T constitutional exercise and not a Court congress, so whatever decisions we make as a party bind all the membership, that the EOC held in Harare on 27th December 2020 was a nullity and stands condemned with contempt.



Notes with disdain the deviant behaviour of the Secretary General in the run up and during the Extraordinary Congress

RE: LEGAL OPINION re EXTRAORDINARY CONGRESS (27 DECEMBER, 2020)

As head of the legal team that has been representing the MDC-T in various legal challenges that arose from the implications of the Supreme Court judgment in **SC 56/20**, I believe it is my professional duty to offer the legal opinion below in the light of differences that appear to be emerging among the leaders of your party.

Whatever differences may be emerging, it is important that you make your decisions on the basis of an informed legal position. Given the seriousness of the issues arising, you may require more than one legal opinion.

I am aware of the following facts:

1. At some point in time on 27 December 2020, the extraordinary Congress was duly called to order and opened at the Rainbow Towers in Harare.
2. The delegates constituting the extraordinary Congress were advised of the sole purpose of the meeting, namely "to elect a President of the party to replace the late Dr. Morgan Richard Tsvangirai".
3. The four candidates who had been duly nominated were introduced to the delegates. The four candidates were Dr. Thokozani Khupe, Morgan Komichi, Elias Mudzuri and Douglas T. Mwonzora.

4. Denounce the so called EOC resolutions circulating on Social Media and accordingly dismiss them as a nullity with no effect on whatsoever discussions and resolutions made by this council.



5. Pursuant to article 18 of the MDC T cons, the current Standing committee members have positions affirmed until next EOC at a date that shall be determined considering the readiness of the electoral register of 2014 structures, resources to support the electoral process.
