5. ■■...study intervention due to ENVIRONMENTAL EXPOSURE.

EX 1.) • A female family member or healthcare provider reports that she is pregnant after having been exposed to the study intervention by INHALATION or SKIN CONTACT■■■

6. ■■...study intervention due to ENVIRONMENTAL EXPOSURE.

EX 2.) • A male family member or healthcare provider who has been exposed to the study intervention by INHALATION or SKIN CONTACT then exposes his female partner prior to or around the time of conception.

7. Since the exposure information DOES NOT PERTAIN TO THE PARTICIPANT ENROLLED IN THE STUDY, the information is NOT RECORDED on a CRF(case report file); however, a copy of the completed Vaccine SAE Report Form is maintained in the investigator site file.

8. Abnormal pregnancy outcomes are considered SAEs. If the outcome of the pregnancy meets the criteria for an SAE (ie, ectopic pregnancy, spontaneous abortion, intrauterine fetal demise, neonatal death, or congenital anomaly)...

15. Male Participant Reproductive Inclusion Criteria

- Be ABSTINENT from heterosexual INTERCOURSE WITH A FEMALE OF CHILDBEARING POTENTIAL as their preferred and usual lifestyle (ABSTINENT ON A LONG-TERM and PERSISTENT BASIS) and AGREE to REMAIN ABSTINENT.
