### Britain's heroes

SIR - The Common Sense Group (59 Conservative MPs and seven peers) was formed to speak for the silent majority of voters tired of being patronised by elitist bourgeois liberals whenever issues such as immigration or law and order are raised.

Part of our mission is to ensure that institutional custodians of history and heritage, tasked with safeguarding and celebrating British values, are not coloured by cultural Marxist dogma, colloquially known as the "woke agenda".

So, when National Trust directors implicitly tarnished one of Britain's greatest sons, Winston Churchill, by linking his family home, Chartwell, with slavery and colonialism, 20 of the group wrote to the Culture Secretary requesting he review the trust's funding applications to public bodies.

History must neither be sanitised nor rewritten to suit "snowflake" preoccupations. A clique of powerful, privileged liberals must not be allowed to rewrite our history in their image. Home secretary Priti Patel ignored warnings from at least two senior colleagues to stop targeting immigration lawyers after a knifeman threatened to kill a solicitor last month in <u>an attack linked to her rhetoric</u>, the *Observer* can reveal.

Jacob Rees-Mogg, the Leader of the House of Commons, has sparked a backlash after he accused Unicef of "playing politics" in its announcement that it would help to feed children in the UK for the first time.

The charity said earlier this week that it would begin an emergency response in the UK to help feed children affected by the coronavirus outbreak.

The Sheila McKechnie Foundation foundation said the findings came after years of ever-tightening restrictions on charity campaigning, including lobbying restrictions, & the use of "gagging clauses" in grants & contracts to prevent charities openly criticising government policy.

# UK charities call for end to 'gagging law' in run-up to elections

NGO leaders say Lobbying Act stops them from representing the most vulnerable in society

Leading charities are calling on the next government to lift the legal gag that prevents them from campaigning for the poor and marginalised in society.

Heads of non-governmental organisations, including Friends of the Earth, Shelter, Liberty, End Violence Against Women, the Quakers and the Howard League, have written to all of the main political parties calling for greater freedom to speak out.

Nine out of 10 campaigners said they thought the freedom to organise, speak out or protest was under threat.

Over half (56%) felt conditions had got worse over the past year, while 72% said negative media coverage was a threat to their freedom to campaign.



Politicians & the media are out of touch with public attitudes to campaigning. Over half of respondents felt the public was increasingly positive about social justice issues, citing widespread support for #BlackLivesMatter & Marcus Rashford's action over food poverty. Agency.

Halima Begum, the director of the race equality charity Runnymede Trust, was criticised in parliament by the women & equalities minister, Liz Truss, after saying the government sought to divisively prioritise the white working class at the expense of ethnic minorities.

Divisive idiot Liz Truss called Begum's comments "appalling", saying they reflected "an attitude on the left of politics that says: 'If you're not from an oppressed group, you're not entitled to an opinion'.

Truss & others spout dangerously misleading populist garbage.

"It's a grave concern to see charity leaders being attacked at a time when charities' funding is drying up. Increasingly, the Govt appears to engage with independent charities in a one-way process, making clear that it's their way or the highway if you dare disagree with policy."

The chief executive of the Sheila McKechnie Foundation, said: "Civil society will keep working to defend rights & build a better world out of the pandemic. It's time for politicians to work with us, even where we don't always agree, not make us fodder in phoney culture wars."
