**Senate Report Written in 1973, says “Since March 9, 1933, the United States has been in a state of declared national emergency...Under the powers delegated by these statutes, the president may: seize property;...**

seize commodities; assign military forces abroad; institute martial law; seize and control all transportation and communication;...restrict travel; and, in a plethora of particular ways, control the lives of all American citizens.”

The president can act through Executive Order, Presidential Proclamation, or through his many agencies, which include most of the alphabet agencies.

In the introduction to Senate Report 93-549:

"A majority of the people of the united States have lived all their lives under emergency rule.-(Exhibit 2)

Remember, this report was produced in 1973. The introduction goes on to say:

"For 40 years, freedoms and governmental procedures guaranteed by the Constitution have, in varying degrees, been abridged by laws brought into force by states of national emergency."

The introduction continues:

"And, in the united States, actions taken by the government in times of great crisis have -- from, at least, the Civil War -- in important ways shaped the present phenomenon of a permanent state of national emergency."

Where does (Exhibit 2) come from? In our Constitution, could there be some section which could the Senate Report is referring to?

"In Article 1, Section 9 of the Constitution of the United States of America, we find the following words:

"The Privilege of the Writ of Habeas Corpus shall not be suspended, unless when in Cases of Rebellion or Invasion the public Safety may require it."

Known as the War Powers Act.

5th Amendment Constitution (Exhibit 3):

"No Person shall be held to answer for...unless on a Presentment or Indictment of a Grand Jury, except in Cases a rising in the Land or Naval forces or in the Militia, when in actual Service in Time of War or public Danger;..."

If that is, in fact, the case, and we are under a war emergency in this country, then there would be evidence of that war emergency in the current law that exists today...

USC or "United States Code"

12 USC Section 95b

"The actions, regulations, rules, licenses, orders and proclamations heretofore or hereafter taken, promulgated, made, or issued by the President of the United States or the Secretary of the Treasury since March the 4th, 1933,...

...pursuant to the authority conferred by Subsection (b) of Section 5 of the Act of October 6th, 1917, as amended [12 USCS Sec. 95a], are hereby approved and confirmed. (Mar. 9, 1933, c. 1, Title 1, Sec. 1, 48 Stat. 1.)".
