Ratcliffe told Fox News that China intends "to dominate economically,

16. militarily and technologically, and is the only country capable of challenging American supremacy across the board."

"All of the threat streams that we have, from all aspects, militarily, economically, supply chain issues, foreign investment, technologically, cyber issues,

17. cyber warfare, 5G, telecommunications — China is in all of those and they are the only country to be in that space and the only country that threatens America supremacy," Ratcliffe told Fox News.

When asked whether the United States was in an offensive or defensive position

18. with regard to China, Ratcliffe said the U.S. remains in an offensive place.
