2.1 \*Authorize the Board of Supervisors to sign a letter to Governor Newsom with Urgent Request for Additional Vaccine Pacheco says County now is doing 30,000 shots a week. We are now efficient after so issues at start.

Magisg: local control is always best. California had been challenged to get the shots out to counties. (EDITORIAL ALTHOUGH I heard on radio that counties have been uneven in their approach too. ). Magisg: appreciates the team the county had.

Fresno got some direct dollars and so we asked to move together. Education, contact tracing, isolation quarantine support was focus. \$7.4million contracts. EOC was large contract. Exceptional Parents unlimited too. African American Coalition. We worked on a local data base and

standardization. 800 individuals benefited from Isolation Quarantine aspect. Thru Nov 30, 2020

As different funding is made available the scope of work allows us to put the money in the correct bucket.

AL-20 (limited agricultural, 20-acre minimum size). Magisg: this is consistent with our General Plan and we have no opposition. Approved 5-0

5. \*Consider appeal of Planning Commission's denial of Variance Application No. 4084 proposing to allow the creation of a 1.18-acre parcel from an existing 40.00-acre parcel in the AE-20 (Exclusive Agricultural, 20-acre minimum parcel size) Zone District (located on South Rolinda

Avenue, between Jensen Avenue and North Avenue, west of the City of Fresno) Supervisors say they have all spoke with Jeff Roberts on this item. This is also tied to item #6

Quintero says he spoke with Darius Assemi as well. Jeff Roberts: we think we can make case for this parcel. This small parcel will have no to little change. No improvements will be caused by this as the improvements have been there for decades and pre-dates ANY zoning and the

Williamson Act. There are other parcels that are already smaller than the 20 acres. This property owner wants to enjoy the same situation as his surrounding neighbors. We would like a Right to Farm addition as well. This is 90 year old home. A parcel line should be drawn around

it. Magisg: you can make the findings needed to grant this variance. Roberts: yes. All we want to do is carve the parcel from the farm. Pacheco: why did staff deny this? Staff: Planning Commission denied it. They could not find 1,2&4 of findings. Applicant: we want to carve the

house as the rest of farm has been sold. Pacheco: why not leave it as part of farm? Laws were created as we didn't want the farms carved up. But after the fact want to keep home. No one is living in it now. If someone was living in it I could see a reason but not when the person

living in it has moved out. Roberts: this has coexisted for 90 years and it can coexist for another 90 years. Pacheco: why not sell it with home as part of farm? Roberts: new owner doesn't want home. Magisg: can the home be demoed and plant trees there ? Roberts: no agreement was

made that building needs to remain. Pacheco: surprised the homeowner not living there. By right to farming already exists. Mendes: even carved out there is still Right to Farm meaning the homeowner knows that there is farming surrounding it. Magisg: a precedent has been set as

there are many parcels carved out of 20 and 40 acre farms. We have been faced with similar projects. We sometimes were family wanted to remain in home and continue to farm. This doesn't seem to exist here. But is don't see how carving this out will be detrimental as there is

Right to Farm on this parcel. Approved 4-1 with Pacheco voting NO. Because that passed Item 6 will now need to be heard.

6. Consider petition for partial Cancellation of Agricultural Land Conservation Contract No. 3342 filed on behalf of C & A Farms, LLC. (located on South Rolinda Avenue, between Jensen Avenue and North Avenue, west of the City of Fresno Super. Dist. 1 APN 25-041-37s);

Jeff Roberts: a penalty will need to be paid but hope Supervisors will approve this. Approved 5-0

Another Appeal of Planning Commission. 7. Consider Appeal of Planning Commission's denial of Unclassified Conditional Use Permit Application No. 3626, proposing to allow a solid waste processing facility (asphalt and concrete crushing with on-site material storage and off-site

delivery) on a 22.44-acre parcel in the AE-20 (Exclusive Agricultural, 20-acre minimum parcel size) Zone District; and if appeal is granted and the Planning Commission's denial of Unclassified Conditional Use Permit Application No. 3626 is overturned: Some of the Supervisors have

spoken to Larry Westerlund about this. Magisg says he heard from many people against this project with complaints of dust, aesthetics and will hurt farming. Pacheco: Planning Commission denied this unanimously. next: Larry Westerlund (former Councilman) We think the findings can be

made. There is a lot of growth on eastern side of County causing lots of excavation and debris. There is no facility like this recycling on East side. Commercial nursery and a lighting company near by. Former mushroom ■ factory too.

Want to plant some almonds and recycling will only be on right side of parcels. Take in asphalt and use a grinder to crush it with water to keep dust down. (Shows video of grinder) Out into hopper, crushed and sent via conveyor to a pile. Westerlund: not noisy, dusty etc. (video

sure sounded loud to my ears!). Can use McCall to go north/south and 180 for east and west. No Adverse finding: probably overly broad to say no impact. You can always find an impact. But Sound study showed it is quieter than morning traffic. Dust mitigation letter submitted

Planning Commission had concern on dust. We are asking for 2.7 acres for this grinder with rest will remain farming. Is there much difference on dust and noise from almond farming v grinder? Appellant: we have worked in county for 43 years. We are not a fly by night company.

In a previous recycling center was surrounded by housing but no concerns. We had to leave due to Clovis Unified bought lot for a school and thus we knew our time was limited. We had another lot but Cal Trans ended up limiting our access to 180. The video showed an old grinder but

new ones are much quieter. Due to water spray there is no dust. Pacheco: we were told you spoke to neighbors before you bought this parcel. What changed? A: they must imagine the loud grinder shown in video? We are surrounded by almond farming. They have no issues with us.

Pacheco: too bad Cal Trans changed their minds on your other location as that seemed ideal. But that is State of California for you. Opposition Public: we have been here since '82. Ed Dunkel is against this too.

I have seen too much "we will do this and that and it will be beautiful" and it never ends up that way. This recycling center is not good for this area. Next: we did not know about this before this was proposed. I was approached about selling my property as they were already in
