8. Has the maintenance contract on Unite's unopened Bham property been competitively tendered? How much was it for, where and when did this tender appear, and how was the contractor appointed?

9. What is the full list of contracts let by Unite in relation to the Birmingham building project? How were these tendered?

10. What is the role of Blackhorse HCC Ltd, a Unite controlled company reported as owning 76% of the Bham conference centre and hotel? Why is this company used, what powers does it have, how have the directors been appointed, how does it report to the Unite Executive?
