- 4, As it stands court applications were done in March 2017 & the courts took too long to order the immediate removal of these land barons. Judgement was pass in February 2019 & 9 months notice was issued to all sitting home owners to stop building & evacuate.
- 5, The home owners were give notice 9 months which expired on 31st of Oct 2019. The Sherrif was instructed on 13 Feb 2020 at which point country went in to Covid period.
