In late JANUARY we collected the first examples of pro-Kremlin disinformation spinning conspiracy theories about the origins of COVID-19. (2/20) <https://t.co/iAbo00JH56>

In FEBRUARY disinfo outlets kept amplifying conspiracy theories about COVID-19, no matter how ridiculous. The @WHO warned that the pandemic was accompanied by "infodemic": an unprecedented flood of false or inaccurate information about coronavirus. (3/20) <https://t.co/uJXJlyCWez>

In MARCH Josep Borrell, the head of the European External Action Service, warned: "disinformation can kill". <https://t.co/9bZknYDtfX>

In APRIL global activist network @Avaaz found that harmful misinformation on coronavirus was shared over 1.7 million times on Facebook and viewed an estimated 117 million times. (5/20) <https://t.co/WTVAGknLb5>

The eventual slowing down of infection rates in Europe decreased the volume of COVID-19 related disinformation. In MAY it was no longer cool to fuel anti-vaxx moods on Russian TVs. Oscar-winning film director N.Mikhalkov had to learn it the hard way. (6/20) <https://t.co/nKGAhk87RP>

Nonetheless, Disinformation narrative about "secret labs", an old darling of pro-Kremlin disinformation, found new prominence, as it was increasingly adopted by Chinese sources. (7/20) <https://t.co/Yk49cJgjFB>

Disinformation campaign aiming to obfuscate the Kremlin's responsibility for downing flight #MH17 continued into 6th year. As more and more evidence of Russia's direct involvement came to light, pro-Kremlin disinformation began grasping at

In AUGUST protests against the results of rigged presidential election began in Belarus. To aid the embattled dictator, Russian media “specialists” were soon dispatched to the country. (11/20)

THERE IS NO EVIDENCE

London has no evidence of Moscow's complicity in Skripals' poisoning

There is no evidence that Navalny was poisoned

London continues its massive anti-Russian provocation, people have been officially indicted

THE POISONING IS A PROVOCATION

It's a provocation to spoil relations between Russia & Germany in an attempt to stop Nord Stream 2

British authorities are exploiting the case for anti-Russian propaganda

THE WEST IS EXPLOITING POISONING

Poisoning of Navalny is exploited by the West to impose sanctions against Moscow

Skripal poisoning was staged by the British to divert attention from "unsuccessful Brexit talks"

THE POISONING WAS STAGED

The West staged a show with the delivery of an aircraft to transport Navalny to Germany

Western journalism is dominated by Russophobia and prefers fantasy to objective reporting

WESTERN MEDIA IS RUSSOPHOBIC

Russophobic Western media push narrative of Putin's role in Navalny poisoning

Alcoholism, drug addiction, stress... are the inevitable occupational diseases of the traitor. As a result—heart attacks, strokes, traffic accidents — and, finally, suicide

THEY DID IT THEMSELVES

Navalny could have caused his coma himself. A few days before hospitalization, he had problems with nutrition and digestion

It is said that the Russians have deployed a chemical weapon of military level. But nobody is dead!

IF IT WAS NOVICHOK, HE WOULD HAVE DIED

The symptoms of Navalny's alleged poisoning are absolutely uncharacteristic of the use of the Novichok nerve agent

Theresa May is trying to deal with her political enemies by bringing up the Skripal case

IT'S POLITICS

Poisoning Navalny manifests the fierce political struggle in Germany

Novichok, which poisoned the Skripals was produced and patented in the US

MADE IN USA

Novichok is not produced in Russia, but in Georgia & the US

Poisoning could have been carried out by foreign special services

SECRET SERVICES

The alleged "poisoning" could have been orchestrated by Western special forces

May's government has ignored the repeated proposals by the Russian side for constructive cooperation in the investigation of this case

NO COOPERATION

Berlin refuses to cooperate and provide information that would at least somehow verify the statements it made
