News outlets that have demonstrated flexibility and responsiveness around their reporting during the pandemic—like <a href="mailto:@kloopnews"><u>@kloopnews</u></a> <a href="mailto:@istories\_media"><u>@istories\_media</u></a> and KRIK—have reaped the benefits of a public demand for reliable sources of trustworthy

information (4/10)

Some news outlets turned to crowdfunding to support their activities and saw a rise in interest among the public to contribute to independent journalism, both financially and through contributions to the stories themselves (5/10)

One way to encourage ongoing public engagement—besides well-reported stories and solid sourcing—is to develop new methods for presenting information in clear and comprehensive ways, like through innovative technology and web design (6/10)

Many independent outlets will always rely on donors in some way. But they need to find ways to adapt, protect core activities, and survive at times when money is short. Those that are able to survive will have a vision, long-term planning, and efficiency in spending (7/10)

Media outlets that are flexible—both in terms of the type of news they cover and how they cover it—can capitalize upon unexpected opportunities to continue exposing transnational kleptocracy and its devastating impact on people's health and well-being (8/10)
