"Can you believe that the Democrats would say that Congress's ability to speak freely on the floor doesn't apply to Trump speaking at a rally" is a hell of a defense

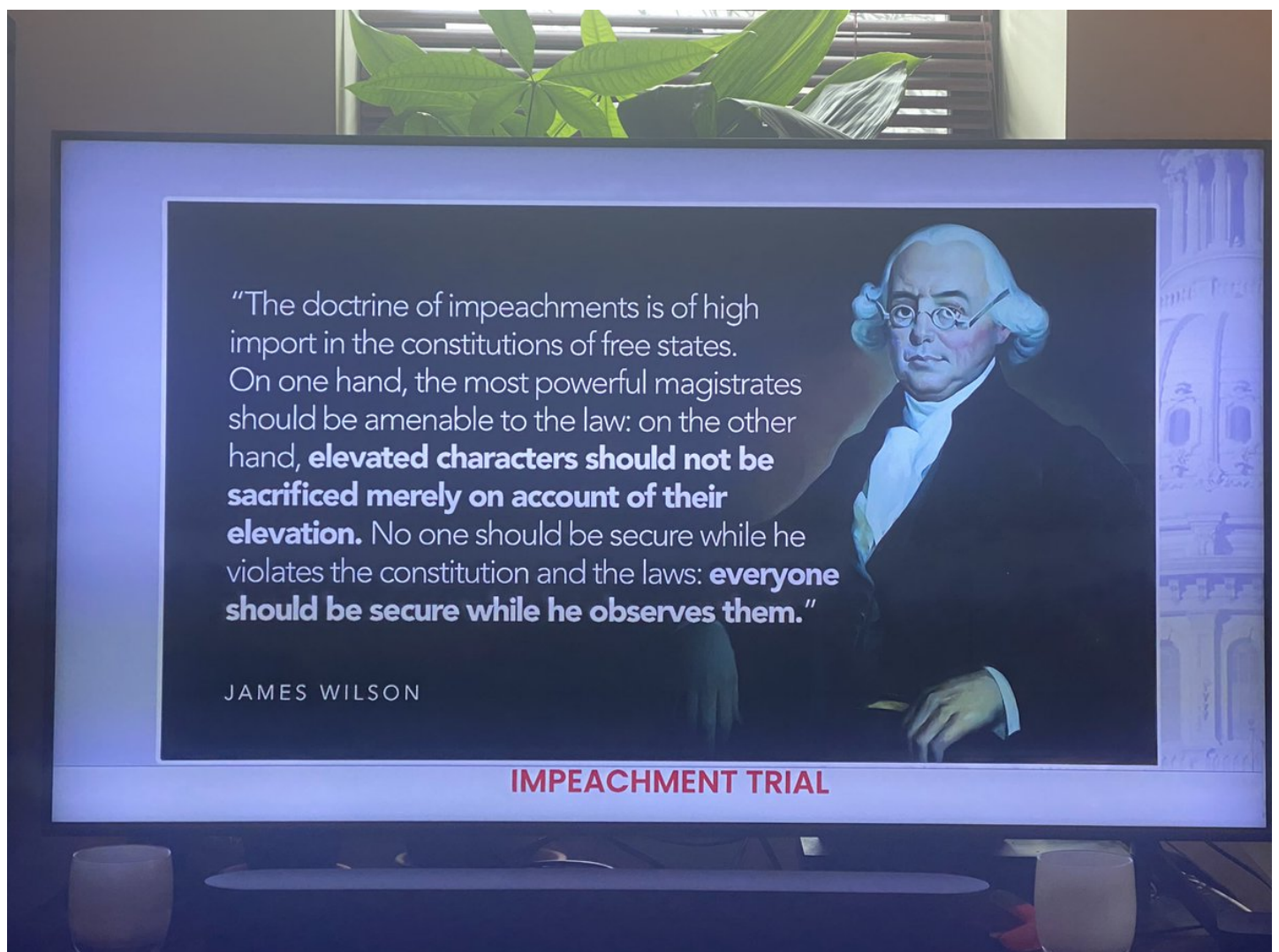
"We have to ignore that only one side here actually gave a speech that led to an attack on Congress" is a hell of a defense

"An impeachment trial is actually a law against free speech" is a hell of a defense

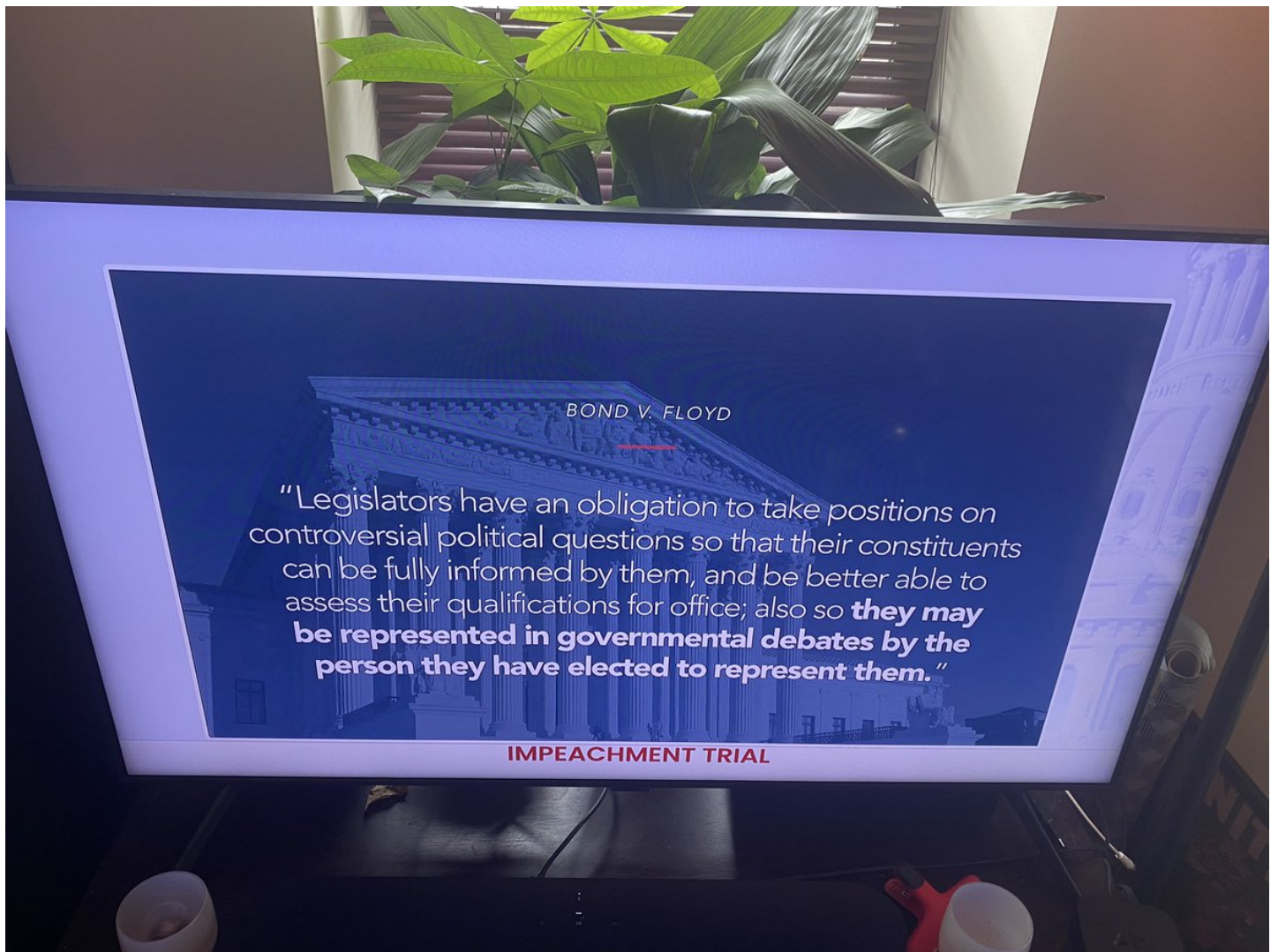
"The Constitution has limits on Congress's impeachment powers that aren't in the text" is a hell of a defense
